

INFORMATION ON THE PROCESSING OF PERSONAL DATA

WHAT IS THE PURPOSE OF THIS DOCUMENT?

The purpose of this document is to provide information on the conditions under which the processing of personal data provided by you will be carried out. If the following text of this document refers to "us" or "our company", it means **Pragosport, a.s.**

WHY WILL MY PERSONAL DATA BE PROCESSED?

By registering at www.ebasketball.cz you have concluded a contract with our company and you have become our customer. The purpose of personal data processing is to provide services related to the concluded contract, i.e. with active participation in events, competitions and tournaments in ebasketball (playing basketball virtually). In order to provide you with these services, we must process your personal data. There is no automated decision-making or profiling process when processing your personal data by our company.

WHO WILL PROCESS MY PERSONAL DATA?

The controller of personal data is **Pragosport, a.s.**, with its registered office in Prague 6, Na Ořechovce 579/6, POSTAL CODE: 162 00, ID: 186 28 010, registered in the Commercial Register kept by the Municipal Court in Prague, Section B, Insert No. 755, Contact details: info@ebasketball.cz, www.ebasketball.cz

WHAT PERSONAL DATA WILL BE PROCESSED AND ON WHAT LEGAL BASIS?

For the purpose of fulfilling the concluded contract, we will process your identification and contact data, including any updates made by you, as well as the date and time of registration and its eventual termination. We will also process: name, surname, nick name, email, date of birth, citizenship, team name. The legal basis is the performance of the contract.

We will also use your contact details to send you information about events and tournaments, results lists, information about what's happening in ebasketball, news from the world of ebasketball players and games, new partners ("commercial communications"). The legal basis for this processing is the legitimate interest of our company in the development and improvement of the quality of our products and services. These commercial communications may be terminated at any time in a simple manner as set forth in each message.

The provision of personal data is not obligatory, if you do not provide us with personal data marked as mandatory during registration, we will not be able to provide you with the relevant service and we will not be able to enter into an agreement with you on its provision.

WHO WILL HAVE ACCESS TO MY PERSONAL DATA?

Access to your personal data is granted to our company employees who are entrusted with specific tasks related to the purpose of the processing of personal data and to processors, such as the tournament and communication organiser, the supplier of the mailing system, suppliers of technical support, e.g. database system, etc. The current list of processors is available on our company's website. Your personal data will be processed in the EU, especially in the Czech Republic.

HOW LONG WILL MY PERSONAL DATA BE STORED BY YOUR COMPANY?

Your personal data will be processed for the entire duration of the contract and subsequently for the time strictly necessary to secure legal claims arising from the contract, such as mutual settlement of rights and obligations. With regard to the limitation periods set by the Civil Code, we will keep your personal data for a period of 7 years from the termination of the contractual relationship.

WHAT ARE MY RIGHTS IN CONNECTION WITH THE PROCESSING OF PERSONAL DATA?

You have the right to request access to your data at any time - this means that, upon your request, we will provide you with information about what personal data we are processing, for what purpose, from what source the personal data was obtained, to whom your data was provided and the intended period of time for which it will be stored.

You have the right at any time to request the correction of inaccurate personal data, or their addition if they are incomplete. You also have the right to request the deletion of personal data that are no longer needed for the purpose for which they were originally collected or that the controller is no longer authorized to use for other reasons.

You have the right to request the restriction of the processing of your personal data - this means that you can ask us not to delete your data for which we would otherwise be obliged to do so, and you can also ask us not to process your personal data further until it is clear whether the data processed is accurate or whether your objection to the processing of your personal data has been raised on reasonable grounds (see right to object below).

You have the right to the portability of your personal data - this means that you can request that we provide you with the personal data processed by us (if it is processed by automated means) in electronic form so that it is easily transferable to another controller (service provider). This right only applies to personal data that we have collected in electronic form on the basis of your consent or on the basis of a contract.

You have the right at any time to object to the processing of your data for direct marketing purposes (sending business offers). If you do so, your personal data will no longer be used for this purpose. You also have the right to object to the processing of your personal data based on our legitimate interest, in which case we will only continue to process your data if it is demonstrated that there are compelling legitimate grounds for doing so.

HOW CAN I EXERCISE MY RIGHTS?

You exercise your rights with the personal data controller, which is our company. You can contact us in writing or by e-mail (contact details are given above).

HOW TO PROCEED IF I BELIEVE THAT THE PROCESSING OF MY PERSONAL DATA HAS VIOLATED THE LAW OR THE EUROPEAN DATA PROTECTION REGULATION?

In this case, you have the right to file a complaint with the Office for Personal Data Protection.
